7 **A Resolution confirming an award by the Board of Control of a one-year professional**  
8 **service contract with Children’s Hospital Medical Center of Akron, Division of Adolescent**  
9 **Medicine for physician and medical services in the Summit County Juvenile Detention**  
10 **Center, for a total amount not to exceed \$228,735.00, for a term from 1/1/17 through**  
11 **12/31/17, for the Court of Common Pleas – Juvenile Division, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held December 7, 2016, awarded a one-  
14 year professional service contract with Children’s Hospital Medical Center of Akron, Division of  
15 Adolescent Medicine for physician and medical services in the Summit County Juvenile  
16 Detention Center, in an amount not to exceed \$228,735.00, for a term from 1/1/17 through  
17 12/31/17; and

19 WHEREAS, pursuant to section 117.08(a) of the Codified Ordinances of the County of  
20 Summit, contracts for professional services with a physician are exempt from competitive  
21 bidding; and

23 WHEREAS, County Council finds and determines, after reviewing all pertinent  
24 information, that the aforementioned professional service contract with Children’s Hospital  
25 Medical Center of Akron, Division of Adolescent Medicine is necessary and in the best interest  
26 of the County of Summit;

28 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
29 of Ohio, that:

33 The award by the Board of Control of a one-year professional service contract with  
34 Children’s Hospital Medical Center of Akron, Division of Adolescent Medicine for physician  
35 and medical services for the Summit County Juvenile Detention Center, for a total amount not to  
36 exceed \$228,735.00, for a term from 1/1/17 through 12/31/17, is hereby confirmed and the  
37 County Executive is hereby authorized to execute such professional services contract.

41 This Resolution is hereby declared an emergency in the interest of the health, safety and  
42 welfare of the citizens of the County of Summit, and for the further purpose of timely obtaining  
43 the physician and medical services for the Summit County Juvenile Detention Center.

16 121.22 of the Ohio Revised Code.


