7 **A Resolution, pursuant to Section 177.13 of the Codified Ordinances of the County of**
8 **Summit, ratifying purchases by the County Executive from REXEL, as a Best Practical**
9 **Source, for operations within the Executive's Department of Sanitary Sewer Services in**
10 **calendar year 2016, in a total aggregate amount not to exceed \$70,522.18, for the**
11 **Executive's Department of Sanitary Sewer Services, and declaring an emergency.**

13 WHEREAS, Section 177.13 of the Codified Ordinances of the County of Summit
14 requires that purchases by an officeholder exceeding \$50,000.00 in the aggregate in any calendar
15 year, where no additional competitive quotes or bids have been taken, shall be made only upon
16 authorization of County Council; and

18 WHEREAS, the Department of Finance and Budget and the Board of Control have
19 previously approved purchases by the County Executive from REXEL, as a Best Practical
20 Source, for operations within the Executive's Department of Sanitary Sewer Services in calendar
21 year 2016, in a total aggregate amount not to exceed \$70,522.18; and

23 WHEREAS this Council finds and determines, after reviewing all pertinent information,
24 that it is necessary and in the best interest of the County to ratify purchases by the County
25 Executive from REXEL, as a Best Practical Source, for operations within the Executive's
26 Department of Sanitary Sewer Services in calendar year 2016, in a total aggregate amount not to
27 exceed \$70,522.18;

29 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
30 of Ohio, that:

34 This Council hereby ratifies purchases by the County Executive from REXEL, as a Best
35 Practical Source, for operations within the Executive's Department of Sanitary Sewer Services in
36 calendar year 2016, in a total aggregate amount not to exceed \$70,522.18.

40 This Resolution is hereby declared an emergency in the interest of the health, safety and
41 welfare of the citizens of the County of Summit, and for the further reason to immediately ratify
42 necessary purchases for operations within the Executive's Department of Sanitary Sewer




