7 **A Resolution authorizing the County Executive to advertise for bids for a five-year full**  
8 **maintenance service contract for Heating, Ventilation and Air Conditioning at the Summit**  
9 **County Jail, for an estimated total cost not to exceed \$675,000.00, for the Executive's**  
10 **Department of Administrative Services-Physical Plants Division, and declaring an**  
11 **emergency.**

13 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit  
14 requires this Council's authorization for the County Executive to advertise for bids; and

16 WHEREAS, the County Executive wishes to advertise for bids for a five-year full  
17 maintenance service contract for Heating, Air Conditioning and Ventilation ("HVAC") at the  
18 Summit County Jail, located at 205 E. Crosier St, Akron, Ohio 44311, in Council District 4, for  
19 an estimated total cost not to exceed \$675,000.00; and

21 WHEREAS this Council finds and determines, after reviewing all pertinent information  
22 that it is necessary and in the best interest of the County of Summit to authorize the Executive to  
23 advertise for bids for the aforementioned five-year full maintenance service contract for HVAC  
24 at the Summit County Jail;

26 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
27 of Ohio, that:

31 The County Executive is authorized to advertise for bids for a five-year full maintenance  
32 service contract for Heating, Air Conditioning and Ventilation ("HVAC") at the Summit County  
33 Jail, located at 205 E. Crosier St, Akron, Ohio 44311, in Council District 4, for an estimated total  
34 cost not to exceed \$675,000.00.

38 This Resolution is hereby declared an emergency in the interest of the health, safety and  
39 welfare of the citizens of the County of Summit, and for the further reason that it authorizes the  
40 Executive to immediately advertise for bids for the aforementioned five-year full maintenance  
41 service contract for HVAC at the Summit County Jail.

45 Provided this Resolution receives the affirmative vote of eight members, it shall take  
46 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
47 effect and be in force at the earliest time provided by law.
