7 **A Resolution authorizing the County Executive to execute a six-month contract with the**
8 **County of Summit Alcohol, Drug Addiction and Mental Health Services Board for the**
9 **County Sheriff's Office to provide non-Medicaid behavioral health services through its**
10 **Drug Abuse Resistance Education unit to the Board, for the period 1/1/17 through 6/30/17,**
11 **for payment in the total amount of \$43,450.00, for the Sheriff, and declaring an emergency.**

13 WHEREAS, the County of Summit Alcohol, Drug Addiction and Mental Health Services
14 ("ADM") Board wishes to execute a six-month contract with the County for the County Sheriff's
15 Office to provide non-Medicaid behavioral health services through its Drug Abuse Resistance
16 Education ("D.A.R.E.") unit to the ADM Board, for the period 1/1/17 through 6/30/17, for which
17 the ADM Board has agreed to pay the County the total amount of \$43,450.00; and

19 WHEREAS, the County wishes to provide said services through the D.A.R.E. unit; and

21 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
22 that it is necessary and in the best interest of the County of Summit to authorize the County
23 Executive to execute said contract with the ADM Board for the aforementioned reason;

25 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
26 of Ohio, that;

30 The County Executive is hereby authorized to execute a six-month contract with the
31 County of Summit Alcohol, Drug Addiction and Mental Health Services ("ADM") Board for the
32 County Sheriff's Office to provide non-Medicaid behavioral health services through its Drug
33 Abuse Resistance Education ("D.A.R.E.") unit, for the period 1/1/17 through 6/30/17, for
34 payment in the total amount of \$43,450.00 during the term of the contract.

38 This Resolution is hereby declared an emergency in the interest of the health, safety, and
39 welfare of the citizens of the County of Summit and for the further purpose of immediately
40 authorizing the Sheriff's Office to provide non-Medicaid behavioral health services through its
41 D.A.R.E. unit to the ADM Board in 2017.

45 Provided this Resolution receives the affirmative vote of eight members, it shall take
46 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
47 effect and be in force at the earliest time provided by law.
