12 activities, including Workforce Innovation and Opportunity Act ("WIOA") Adult and Dislocated  
13 Worker programs, WIOA Youth programs, WIOA Administration costs, Medina County WIOA  
14 programs, and other WIOA workforce development activities, in a total amount of  
15 \$3,357,021.00; and

18 that it is necessary and in the best interest of the County of Summit to appropriate the  
19 aforementioned funds in a total amount of \$3,357,021.00 for workforce development activities;
