7 **A Resolution confirming an award by the Board of Control of a purchase contract with**
8 **EMS Innovations, Inc. for one twenty bed mobile hospital with one trailer for equipment**
9 **storage and transport, in an amount not to exceed \$185,565.50, for the Executive's**

13 WHEREAS, the Board of Control, at its meeting held February 8, 2017, awarded a
14 purchase contract with EMS Innovations, Inc. for one twenty bed mobile hospital with one trailer
15 for equipment storage and transport, in an amount not to exceed \$185,565.50; and

17 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
18 that the aforementioned purchase contract with EMS Innovations, Inc. is necessary and in the
19 best interest of the County of Summit;

26 The award by the Board of Control of a purchase contract with EMS Innovations, Inc.,
27 for one twenty bed mobile hospital with one trailer for equipment storage and transport, in an
28 amount not to exceed \$185,565.50, is hereby confirmed and the County Executive is hereby
29 authorized to execute such purchase contract.

33 This Resolution is hereby declared an emergency in the interest of the health, safety and
34 welfare of the citizens of the County of Summit, and for the further reason to immediately
35 confirm the award of the aforementioned purchase contract for a necessary one twenty bed
36 mobile hospital with one trailer for equipment storage and transport.

40 Provided this Resolution receives the affirmative vote of eight members, it shall take
41 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
42 effect and be in force at the earliest time provided by law.

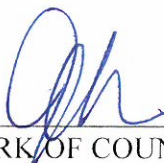

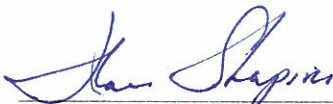
