7 **A Resolution confirming an award by the Board of Control of a construction contract with**
8 **Perrin Asphalt Company for the Men's Community Based Correction Facility Paving and**
9 **Concrete Repair Project, in an amount not to exceed \$67,420.00, for the Executive's**
10 **Department of Administrative Services – Physical Plants, and declaring an emergency.**

12 WHEREAS, the Board of Control, at its meeting held February 22, 2017 awarded a
13 construction contract to Perrin Asphalt Company for the Men's Community Based Correction
14 Facility Paving and Concrete Repair Project located at 264 East Crosier St., Akron, Ohio 44311,
15 in Council District 4, in an amount not to exceed \$67,420.00, subject to confirmation by County
16 Council; and

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
19 that the aforementioned construction contract with Perrin Asphalt Company is necessary and in
20 the best interest of the County of Summit;

22 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

27 The award by the Board of Control of a construction contract with Perrin Asphalt
28 Company for the Men's Community Based Correction Facility Paving and Concrete Repair
29 Project located at 264 East Crosier St., Akron, Ohio 44311, in Council District 4, in an amount
30 not to exceed \$67,420.00, is hereby confirmed and the County Executive is hereby authorized to
31 execute such purchase contract.

35 This Resolution is hereby declared an emergency in the interest of the health, safety and
36 welfare of the citizens of the County of Summit, and for the further reason to immediately award
37 the aforementioned construction contract so that the Men's Community Based Correction
38 Facility Paving and Concrete Repair Project may be completed in a timely manner.

42 Provided this Resolution receives the affirmative vote of eight members, it shall take
43 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
44 effect and be in force at the earliest time provided by law.
