7 **A Resolution authorizing the County Executive to advertise for bids for the Tallmadge**
8 **Avenue Facility Parking Lot Improvement Project, located at 1030 and 1040 Tallmadge**
9 **Avenue, Akron, Ohio 44310, for an estimated total cost not to exceed \$250,000.00, for the**
10 **Executive's Department of Administrative Services-Physical Plants, and declaring an**
11 **emergency.**

13 WHEREAS, it is necessary to repave the parking lots at 1030 and 1040 Tallmadge
14 Avenue, Akron, Ohio 44310, in Council District 2, where OhioMeansJobs and the Main Office
15 of the County Clerk of Court's Title Division is located; and

17 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
18 requires this Council's authorization for the County Executive to advertise for bids; and

20 WHEREAS, the County Executive wishes to advertise for bids for the Tallmadge Avenue
21 Facility Parking Lot Improvement Project, located at 1030 and 1040 Tallmadge Avenue, Akron,
22 Ohio 44310, in Council District 2, for an estimated total cost not to exceed \$250,000.00; and

24 WHEREAS, a copy of the plans and specifications are on file in the Clerk of Council's
25 office; and

27 WHEREAS this Council finds and determines, after reviewing all pertinent information
28 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
29 advertise for bids for the aforementioned Project, for an estimated total cost not to exceed
30 \$250,000.00;

32 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

37 The County Executive is authorized to advertise for bids for the Tallmadge Avenue
38 Facility Parking Lot Improvement Project, located at 1030 and 1040 Tallmadge Avenue, Akron,
39 Ohio 44310, in Council District 2, for an estimated total cost not to exceed \$250,000.00.

43 This Resolution is hereby declared an emergency in the interest of the health, safety and
44 welfare of the citizens of the County of Summit, and for the further reason that it authorizes the
45 Executive to immediately advertise for bids in order to complete the necessary Tallmadge
46 Avenue Facility Parking Lot Improvement Project in a timely manner for the benefit of Summit
47 County residents using the on-site offices such as OhioMeansJobs and the Main Office of the
48 County Clerk of Court's Title Division.
