12 WHEREAS, the Board of Control, at its meeting on February 15, 2017, awarded a IV-D
13 intergovernmental agreement with the County Sheriff for security and process serving for the
14 County Prosecutor's Child Support Enforcement Agency, for a one-year term, from 1/1/17
15 through 12/31/17, in an amount not to exceed \$750,000.00; and

17 WHEREAS, this Council finds and determines after reviewing all pertinent information,
18 that the aforementioned IV-D intergovernmental agreement with the County Sheriff is necessary
19 and in the best interest of the County of Summit;

26 The award by the Board of Control of a IV-D intergovernmental agreement with the
27 County Sheriff for security and processing services for the County Prosecutor's Child Support

29 exceed \$750,000.00 is hereby confirmed and the County Executive is hereby authorized to
30 execute such intergovernmental agreement.

35 welfare of the citizens of the County of Summit and for the further purpose of immediately
36 providing necessary security and processing services for the Prosecutor's Child Support
