7 **A Resolution approving and accepting a resubdivision titled “Peterboro Subdivision Re-Plat #2,” in Springfield Township, for the Executive-Planning Commission and the Engineer, and declaring an emergency.**

11 WHEREAS, on February 23, 2017, the Planning Commission approved a resubdivision
12 titled “Peterboro Subdivision Re-Plat #2,” concerning a subdivision in Springfield Township, in
13 Council District 8; and

15 WHEREAS, under Section 1104.07(c)(5) of the Codified Ordinances of the County of
16 Summit and Section 711.041 of the Ohio Revised Code, the approval and acceptance of this
17 Council is a prerequisite for the recording of a resubdivision of a previously recorded plat, as
18 though the same were a major subdivision; and

20 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
21 that the acceptance and approval of the aforementioned replat is necessary and in the best interest
22 of the County of Summit;

24 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
25 of Ohio, that;

29 The resubdivision, which shall be known as “Peterboro Subdivision Re-Plat #2”, in
30 Springfield Township, in Council District 8, together with restrictions, covenants and easements
31 thereon, is hereby approved and accepted by the County of Summit, to be recorded by the
32 County Fiscal Officer.

36 This Resolution is hereby declared an emergency in the interest of the health, safety and
37 welfare of the citizens of the County of Summit, and for the further reason that it immediately
38 facilitates development in Springfield Township, in Council District 8.

42 Provided this Resolution receives the affirmative vote of eight members, it shall take
43 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
44 effect and be in force at the earliest time provided by law.
