7 **A Resolution confirming an award by the Board of Control of a professional service**  
8 **contract with Greenleaf Family Center to provide assessments to identify individuals who**  
9 **may require enhanced Court services through the Summit County Targeted Community**  
10 **Alternatives to Prison plan, in an amount not to exceed \$122,000.00, for the Executive's**  
11 **Department of Law, Insurance and Risk Management–Division of Public Safety, and**  
12 **declaring an emergency.**

14 WHEREAS, the Board of Control, at its meeting held November 8, 2017, awarded a  
15 professional service contract with Greenleaf Family Center to provide assessments to identify  
16 individuals who may require enhanced Court services through the Summit County Targeted  
17 Community Alternatives to Prison plan, in an amount not to exceed \$122,000.00, subject to  
18 confirmation by County Council; and

20 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
21 that the aforementioned professional service contract with Greenleaf Family Center is necessary  
22 and in the best interest of the County of Summit;

24 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
25 of Ohio, that:

29 The award by the Board of Control of a professional service contract with Greenleaf  
30 Family Center to provide assessments to identify individuals who may require enhanced Court  
31 services through the Summit County Targeted Community Alternatives to Prison plan, in an  
32 amount not to exceed \$122,000.00, is hereby confirmed and the County Executive is hereby  
33 authorized to execute such professional service contract.

37 This Resolution is hereby declared an emergency in the interest of health, safety and  
38 welfare of the citizens of the County of Summit, and for the further reason to immediately  
39 provide the implementation of the Summit County Targeted Community Alternatives to Prison  
40 plan.

44 Provided this Resolution receives the affirmative vote of eight members, it shall take  
45 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
46 effect and be in force at the earliest time provided by law.
