7 **A Resolution confirming an award by the Board of Control of a purchase contract with**  
8 **I2C Technologies for access control and intercom systems for the Women's Community**

14 purchase contract with I2C Technologies for access control and intercom systems for the  
15 Women's Community Based Correction Facility, located in Council District 5, in an amount not  
16 to exceed \$60,706.00, at State Term Pricing, subject to confirmation by County Council; and

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
19 that the aforementioned construction contract with I2C Technologies is necessary and in the best  
20 interest of the County of Summit;


