A Resolution authorizing the County Executive to execute a three-year policing contract with Twinsburg Township, in Council District 1, for the period 1/1/18 through 12/31/20, in exchange for payment by Twinsburg Township of a total amount of \$2,650,759.07, for the Sheriff, and declaring an emergency.

WHEREAS, County Council previously adopted Resolution No. 2014-482, which authorized the County Executive to execute a three-year policing contract with Twinsburg Township in Council District 1, which expires on 12/31/17; and

WHEREAS, Twinsburg Township has requested that the County of Summit enter into a new contract pursuant to which the County Sheriff will provide 11,814.21 Sheriff's Deputy/Sergeant hours, for the period 1/1/18 through 12/31/20, and

WHEREAS, Twinsburg Township has agreed to pay the County \$856,901.72 for the first year, \$883,316.47 for the second year and \$910,540.88 for the third year, for a total amount of \$2,650,759.07 during the three-year term of the contract; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to authorize the County Executive to execute the aforementioned policing contract with Twinsburg Township;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that;

SECTION 1

The County Executive is hereby authorized to execute a three-year policing contract with Twinsburg Township, in Council District 1, pursuant to which the County Sheriff will provide Twinsburg Township with 11,814.21 Deputy/Sergeant hours, for the period of 1/1/18 through 12/31/20, in exchange for payment by Twinsburg Township, in the amount of \$856,901.72 for the first year, \$883,316.47 for the second year and \$910,540.88 for the third year, for a total amount of \$2,650,759.07 during the three-year term of the contract.

SECTION 2

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the citizens of the County of Summit and for the further purpose of immediately providing necessary policing for Twinsburg Township, in Council District 1, effective 1/1/18.

SECTION 3




