7 **A Resolution, pursuant to Section 169.04(h) of the Codified Ordinances of the County of**
8 **Summit, approving and adopting the Report on Staffing for calendar year 2018, for the**
9 **Executive, and declaring an emergency.**

11 WHEREAS, Section 169.04(h) of the Codified Ordinances of the County of Summit
12 requires the County Executive to submit annually a report on staffing which sets forth the
13 number of full-time, part-time and seasonal positions within each job classification, that an
14 office, department, agency, board or commission may employ during the following calendar
15 year; and

17 WHEREAS, the Report on Staffing submitted by the Executive must be adopted by this
18 Council no later than December 31st of each year; and

20 WHEREAS, the Executive has submitted to this Council a Report on Staffing for
21 calendar year 2018; and

23 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
24 that it is necessary and in the best interest of the County of Summit to adopt the Report on
25 Staffing for calendar year 2018;

27 NOW, THEREFORE BE IT RESOLVED, by the Council of the County of Summit, State
28 of Ohio, that:

32 The Report on Staffing for calendar year 2018, which is attached hereto as Exhibit A and
33 incorporated herein by reference, is hereby approved and adopted by this Council.

37 This Resolution is hereby declared to be an emergency in the interest of the health, safety
38 and welfare of the citizens of the County of Summit and for the further reason that it is necessary
39 to immediately approve and adopt the Report on Staffing prior to the deadline established by the
40 Codified Ordinances of the County of Summit.

44 Provided this Resolution receives the affirmative vote of eight members, it shall take
45 effect immediately upon its adoption and approval by the Executive; otherwise it shall take effect
46 and be in force at the earliest time provided by law.
