7 **An Ordinance amending Chapter 113 of the Codified Ordinances of the County of Summit,**  
8 **entitled “Miscellaneous Fees” to add Section 113.14, entitled “Parking Deck Fees,” for the**  
9 **Executive’s Department of Administrative Services, and declaring an emergency.**

10  
11 WHEREAS, the County Executive has reviewed the current Summit County Parking  
12 Deck fees and compared them to parking decks of other Ohio public entities and has concluded  
13 that the current fees no longer reflect the actual cost of parking deck maintenance, including  
14 equipment, materials, supplies and personnel costs; and

15  
16 WHEREAS, the County Executive has proposed increasing the fees for parking in the  
17 Summit County Parking Deck; and

18  
19 WHEREAS, in order to increase the Summit County Parking Deck fees, it is necessary  
20 that Chapter 113 of the Codified Ordinances of the County of Summit entitled “Miscellaneous  
21 Fees” be amended to add Section 113.14, entitled “Parking Deck Fees; and

23 WHEREAS, this Council finds and determines that it is necessary and in the best interest  
24 of the County of Summit to enact section 113.14 to establish a fee schedule for the Summit  
25 County Parking Decks.

27 NOW, THEREFORE, BE IT ORDAINED, by the Council of the County of Summit,  
28 State of Ohio, that:

30 SECTION 1

32 Chapter 113 of the Codified Ordinances of the County of Summit, entitled  
33 “Miscellaneous Fees,” is hereby amended to add Section 113.14, entitled “Parking Deck Fees,”  
34 as follows:

36 **“113.14 Parking Deck Fees**

37  
38 Fees in the following amounts shall be charged by the County of Summit:

<u>Service</u>	<u>Fee</u>
Daily	\$1.25 per ¼ hour \$6 maximum
After 5pm	\$1.25 per ¼ hour \$2.50 maximum
Monthly	County employees: \$66.25 Non County employees: \$72.00

5 SECTION 2

6  
7 This Ordinance is hereby declared an emergency in the interest of the health, safety and  
8 welfare of the citizens of the County of Summit and for the further reason of immediately  
9 providing for fees to compensate the County for utilization of the Summit County Parking Deck.

11 SECTION 3

12  
13 Provided this Ordinance receives the affirmative vote of eight members, it shall take  
14 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
15 effect and be in force at the earliest time provided by law.

17 SECTION 4

19 It is found and determined that all formal actions of this Council concerning and relating  
20 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
21 deliberations of this Council and of any of its committees that resulted in such formal action,  
22 were in meetings open to the public, in compliance with all legal requirements, including section  
23 121.22 of the Ohio Revised Code.
