7 **A Resolution confirming an award by the Board of Control of an extension of a**
8 **professional service contract with Norman R. Johnson, M.D., aka Advanced Correctional**
9 **Healthcare, Inc. for jail inmate medical services, for a six-month period, from 1/1/18**
10 **through 6/30/18, for a total amount not to exceed \$1,100,000.00, for the Sheriff, and**
11 **declaring an emergency.**

13 WHEREAS, County Council previously adopted Resolution No. 2017-195, which
14 confirmed an award by the Board of Control of an extension of a professional service contract
15 with Norman R. Johnson, M.D., aka Advanced Correctional Healthcare, Inc. for jail inmate
16 medical services for a six-month period, from 7/1/17 through 12/31/17, for an amount not to
17 exceed \$170,173.90 per month, for a total amount not to exceed \$1,021,043.40, subject to
18 confirmation by County Council; and

20 WHEREAS, the County of Summit and Norman R. Johnson, M.D., aka Advanced
21 Correctional Healthcare, Inc. wish to enter into an extension of the aforementioned professional
22 service contract for jail inmate medical services, for an additional six-month period, from 1/1/18
23 through 6/30/18, for an amount not to exceed \$183,333.33 per month, for a total amount not to
24 exceed \$1,100,000.00; and

26 WHEREAS, the Board of Control, at its meeting on November 29, 2017, awarded an
27 extension of a professional service contract with Norman R. Johnson, M.D., aka Advanced
28 Correctional Healthcare, Inc. for jail inmate medical services, for a six-month period, from
29 1/1/18 through 6/30/18, for an amount not to exceed \$183,333.33 per month, for a total amount
30 not to exceed \$1,100,000.00, subject to confirmation by County Council; and

32 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
33 that the aforementioned extension of a professional service contract with Norman R. Johnson
34 M.D., aka Advanced Correctional Healthcare, Inc. is necessary and in the best interest of the
35 County of Summit;

37 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

42 The award by the Board of Control of an extension of a professional service contract with
43 Norman R. Johnson, M.D., aka Advanced Correctional Healthcare, Inc. for jail inmate medical
44 services, for six-month period, from 1/1/18 through 6/30/18, for an amount not to exceed
45 \$183,333.33 per month, for a total amount not to exceed \$1,100,000.00, is hereby confirmed and
46 the County Executive is hereby authorized to execute such extension of said professional service
47 contract.
