7 **A Resolution authorizing the County Executive to execute a grant agreement with the City**  
8 **of Green to assist low to moderate income residents with minor home repairs, in an amount**  
9 **not to exceed \$60,000.00, and appropriating funds, for the Executive’s Department of**  
10 **Community and Economic Development, and declaring an emergency.**

12 WHEREAS, the City of Green has set aside \$60,000 to assist low to moderate income  
13 residents in the City with minor home repairs including but not limited to new roofs, electrical  
14 panels and windows;

15  
16 WHEREAS, the County will bid all jobs and expend County Minor Home Repair Funds  
17 for said jobs, for which the County will be reimbursed by the City of Green; and

19 WHEREAS, it is necessary to appropriate funds for the aforementioned purpose, in the  
20 amount of \$60,000.00; and

22 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

23 121.22 of the Ohio Revised Code.


