7 **A Resolution authorizing the County Executive to execute a collective bargaining**
8 **agreement between Ohio Council 8 and Local 3885, Child Support Enforcement Agency, of**
9 **the American Federation of State, County and Municipal Employees, AFL-CIO and the**
10 **County Executive and County Prosecutor, for the period 10/1/17 through 9/30/20, for the**
11 **Executive, which authorizes a three percent (3.0%) increase in pay in each of the three**
12 **years of the agreement, for the Executive, and declaring an emergency.**

14 WHEREAS, a collective bargaining agreement has been reached between Ohio Council 8
15 and Local 3885, Child Support Enforcement Agency, of the American Federation of State,
16 County and Municipal Employees, AFL-CIO and the County Executive and County Prosecutor,
17 for the period 4/1/17 through 3/31/20, which authorizes a three percent (3.0%) increase in pay in
18 each of the three years of the agreement; and

20 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
21 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
22 execute the aforementioned collective bargaining agreement;

24 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
25 of Ohio, that:

27 SECTION 1

29 The County Executive is hereby authorized to execute a collective bargaining agreement
30 between Ohio Council 8 and Local 3885, Child Support Enforcement Agency, of the American
31 Federation of State, County and Municipal Employees, AFL-CIO and the County Executive and
32 County Prosecutor, for the period 10/1/17 through 9/30/20, which authorizes a three percent
33 (3.0%) increase in pay in each of the three years of the agreement.

37 This Resolution is hereby declared an emergency in the interest of the health, safety and
38 welfare of the citizens of the County of Summit and for the further purpose of providing a timely
39 collective bargaining agreement between the Local 3885, Child Support Enforcement Agency,
40 the County Executive and County Prosecutor.

44 Provided this Resolution receives the affirmative vote of eight members, it shall take
45 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
46 effect and be in force at the earliest time provided by law.
