7 **An Ordinance amending Section 169.23(a) of the Codified Ordinances of the County of**
8 **Summit, entitled "Vacation," to include service with the Summit County Land**
9 **Reutilization Corporation as prior service credit towards vacation accumulation, for the**
10 **Executive's Department of Human Resources, and declaring an emergency.**

11
12 WHEREAS, Section 169.23(a) of the Codified Ordinances of the County of Summit,
13 entitled "Vacation," sets forth the County of Summit's policy for the accrual for vacation by
14 employees of the County; and

15
16 WHEREAS, in order to include the prior service credit for employees of the Summit
17 County Land Reutilization Corporation towards vacation accumulation, it is necessary to amend
18 Section 169.23(a); and

20 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
21 that it is necessary and in the best interest of the County of Summit to amend Section 169.23(a)
22 for the aforementioned reason;

24 NOW, THEREFORE, BE IT ORDAINED by the Council of the County of Summit, State
25 of Ohio, that:

27 SECTION 1

29 Section 169.23(a) of the Codified Ordinances of the County of Summit, entitled
30 "Vacation," is hereby amended as set forth in Exhibit A, attached to this Ordinance and
31 incorporated herein as if fully restated.

33 SECTION 2

35 This Ordinance is hereby declared an emergency in the interest of the health, safety, and
36 welfare of the citizens of the County of Summit and for the further reason that it is necessary to
37 immediately amend 169.23(a) of the Codified Ordinances of the County of Summit to
38 immediately include employees of the Summit County Land Reutilization Corporation for prior
39 service credit.

43 Provided this Ordinance received the affirmative vote of eight members, it shall take
44 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
45 effect and be in force at the earliest time provided by law.
