7 **A Resolution authorizing the County Executive to execute an agreement and any other**
8 **documents necessary for an inter-county transfer of funds between the Executive's**
9 **Department of Job and Family Services and the Trumbull County Department of Job and**
10 **Family Services, pursuant to which agreement Summit County will transfer \$12,000.00 in**
11 **Federal Fiscal Year 2018 Community and Protective Service funds to Trumbull County,**
12 **for the Executive's Department of Job and Family Services, and declaring an emergency.**

13
14 Section 5101:9-6-82 of the Ohio Administrative Code authorizes counties to execute a
15 JFS 02719 "Inter-county Agreement and Certification Release and Acceptance of Funds" to
16 engage in inter-county transfers of funds allocated to county departments of job and family
17 services by the Ohio Department of Job and Family Services; and

18
19 WHEREAS, Section 5101:9-6-82(F)(2)(b) provides that a board of county
20 commissioners may assign authority to another party to serve as designee and therefore, grant
21 that party authority to sign an inter-county adjustment agreement on behalf of the county for a
22 specific period of time; and

24 WHEREAS, this Council previously adopted Resolution No. 2017-214, which authorizes
25 the County Executive to execute the JFS 02719 Inter-county Agreement and Certification
26 Release and Acceptance of Funds, and any other documents necessary pursuant to Section
27 5101:9-6-82 for the acceptance by the County Executive's Department of Job and Family
28 Services ("SCDJFS") of inter-county transfers of funds from other Ohio counties, for the period
29 6/14/17 through 6/30/19, and assigns the Executive as designee of the County of Summit to
30 execute said agreements and documents as provided in Section 5101:9-6-82(F)(2)(b), for the
31 period 6/14/17 through 6/30/19; and

33 WHEREAS, Summit County and Trumbull County wish to enter into an agreement
34 pursuant to Section 5101:9-6-82 pursuant to which SCDJFS will transfer \$12,000.00 in Federal
35 Fiscal Year 2018 ("FFY18") Community and Protective Service funds to the Trumbull County
36 Department of Job and Family Services ("TCDJS") in exchange for \$52,000.00 of Federal Fiscal
37 Year 2017 Title XX Base Subsidy funds which will fund prior year Adult Protective Services
38 expenditures; and

40 WHEREAS, while Resolution No. 2017-214 authorizes the Executive to accept the
41 transfer of funds to SCDJFS, it is necessary to authorize the Executive to execute an agreement
42 and any other documents necessary for the inter-county transfer of said \$12,000.00 in FFY18
43 Community and Protective Service funds to TCDJFS; and

45 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
46 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
47 execute the JFS 02719 Inter-county Agreement and Certification Release and Acceptance of
48 Funds, and any other documents necessary pursuant to Section 5101:9-6-82 for the transfer of
49 \$12,000.00 in FFY18 Community and Protective Service funds to TCDJFS;

4 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
5 of Ohio, that:

7 SECTION 1

9 The County Executive is hereby authorized to execute the JFS 02719 Inter-county
10 Agreement and Certification Release and Acceptance of Funds, and any other documents
11 necessary pursuant to Section 5101:9-6-82 for the transfer by the Executive's Department of Job
12 and Family Services ("SCDJFS") of \$12,000.00 in Federal Fiscal Year 2018 ("FFY18")
13 Community and Protective Service funds to the Trumbull County Department of Job and Family
14 Services ("TCDJFS").

16 SECTION 2

18 This Resolution is hereby declared an emergency in the interest of the health, safety and
19 welfare of the citizens of the County of Summit and for the further reason to immediately
20 authorize the transfer by SCDJS of FFY18 Community and Protective Service funds to FCDJFS
21 in exchange for Federal Fiscal Year 2017 Title XX Base Subsidy funds in order to immediately
22 authorize the funding of prior year Adult Protective Services expenditures.

26 Provided this Resolution receives the affirmative vote of eight members, it shall take
27 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
28 effect and be in force at the earliest time provided by law.

32 It is found and determined that all formal actions of this Council concerning and relating
33 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
34 deliberations of this Council and of any of its committees that resulted in such formal action,
35 were in meetings open to the public, in compliance with all legal requirements, including Section
36 121.22 of the Ohio Revised Code.
