A Resolution confirming the award by the Board of Control of a purchase order, pursuant to Section 177.13 of the Codified Ordinances of the County of Summit, authorizing purchases by the County of Summit Medical Examiner from Templar Companies LLC, dba Professional Funeral Services, as a Best Practical Source, for the removal and transport of deceased bodies from death scenes for the period of August 1, 2017 through July 31, 2018, in an amount not to exceed \$50,000.00, for a total aggregate amount not to exceed \$62,500.00 in calendar year 2017, for the County of Summit Medical Examiner, and declaring an emergency.

WHEREAS, Section 177.13 of the Codified Ordinances of the County of Summit requires that purchases by an officeholder exceeding \$50,000.00 in the aggregate in any calendar year, where no additional competitive quotes or bids have been taken, shall be made only upon authorization of County Council; and

WHEREAS, the Department of Finance and Budget and the Board of Control have previously approved purchases by the County of Summit Medical Examiner from Templar Companies LLC, dba Professional Funeral Services, as a Best Practical Source, for the removal and transport of deceased bodies from death scenes in calendar year 2017, in a total aggregate amount not to exceed \$50,000.00; and

WHEREAS, the Board of Control, at its June 29, 2016 meeting, awarded a purchase order with Templar Companies LLC, dba Professional Funeral Services, as Best Practical Source, for the removal and transport of deceased bodies from death scenes, for the period of August 1, 2016 through July 31, 2017, in an amount not to exceed \$25,000.00; and

WHEREAS, the Board of Control, at its April 5, 2017 meeting, awarded a change order with Templar Companies LLC, dba Professional Funeral Services, as Best Practical Source, for the removal and transport of deceased bodies from death scenes, for the period of August 1, 2016 through July 31, 2017, in an amount not to exceed \$25,000.00, for a total contract amount not to exceed \$50,000.00 from August 1, 2016 through July 31, 2017; and

WHEREAS, the Board of Control, at its July 19, 2017 meeting, awarded a purchase order with Templar Companies LLC, dba Professional Funeral Services, as Best Practical Source, for the removal and transport of deceased bodies from death scenes, for the period of August 1, 2017 through July 31, 2018, in an amount not to exceed \$50,000.00; and

WHEREAS, the Medical Examiner has made, or anticipates making, purchases totaling \$12,500.00 for the period August 1, 2017 through December 31, 2017, which exceeds an aggregate of \$50,000.00 for calendar year 2017, which requires the approval of County Council;

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County to confirm the award of a purchase order with Templar Companies LLC, dba Professional Funeral Services, as a Best Practical Source, for the removal and transport of deceased bodies from death scenes for the period of August 1, 2017 through July 31, 2018, in a total amount not to exceed \$50,000.00, for a total aggregate amount not to exceed \$62,500.00 in calendar year 2017;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

 The award by the Board of Control of a purchase order with Templar Companies LLC, dba Professional Funeral Services, as a Best Practical Source, for the removal and transport of deceased bodies from death scenes for the period of August 1, 2017 through July 31, 2018, in a total amount not to exceed \$50,000.00, for a total aggregate amount not to exceed \$62,500.00 in calendar year 2017, is hereby approved, and the County Executive is hereby authorized to execute said purchase order and any necessary related documents.

SECTION 2

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the citizens of the County of Summit, and for the further reason to immediately authorize necessary purchases for the removal and transport of deceased bodies from death scenes in calendar year 2017.

SECTION 3

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.

SECTION 4
