7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **accept the award by the Ohio Department of Public Safety/Office of Criminal Justice**
9 **Services of a Forensic Investigation Training Grant under the Paul Coverdell National**
10 **Forensic Sciences Improvement Act of 2000, in the amount of \$2,119.26, with no local cash**
11 **match requirement, for the period 1/1/18 through 12/31/18, and appropriating the grant,**
12 **for the Medical Examiner, and declaring an emergency.**

14 WHEREAS, the County Medical Examiner has received a Forensic Investigation
15 Training Grant award under the Paul Coverdell National Forensic Sciences Improvement Act of
16 2000 from the Ohio Department of Public Safety/Office of Criminal Justice Services
17 (“ODPS/OCJS”), in the amount of \$2,119.26, with no local cash match requirement, for the
18 period 1/1/18 through 12/31/18; and

20 WHEREAS, this funding will provide for travel and registration expenses for Forensic
21 Investigation courses to be attended by the Medical Examiner’s Forensic Investigators in order to
22 receive education credits for their certification and/or recertification with the American Board of
23 Medicolegal Death Investigators; and

25 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
26 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
27 execute any documents necessary to accept the award of the aforementioned grant from
28 ODPS/OCJS, and to appropriate these grant funds;

35 The County Executive is hereby authorized to execute any documents necessary to accept
36 the award by the Ohio Department of Public Safety/Office of Criminal Justice Services
37 (“ODPS/OCJS”) of a Forensic Investigation Training Grant under the Paul Coverdell National
38 Forensic Sciences Improvement Act of 2000, in the amount of \$2,119.26, with no local cash
39 match requirement, for the period 1/1/18 through 12/31/18.
