7 **A Resolution approving and authorizing salary adjustments for classified non-bargaining**  
8 **employees Pam Murray, Paul Matulavich, William Holland, Kelly Pongracz, Leigh-Ann**  
9 **Slaughter, Kevin Tinney and Angela Just effective retroactively to January 1, 2018, for the**  
10 **Sheriff, and declaring an emergency.**

12 WHEREAS, the County Sheriff wishes to grant salary adjustments for classified non-  
13 bargaining employees Pam Murray, Paul Matulavich, William Holland, Kelly Pongracz, Leigh-  
14 Ann Slaughter, Kevin Tinney and Angela Just based upon job performance and pay equity,  
15 effective retroactively to January 1, 2018; and

17 WHEREAS, because the salary adjustments for the aforementioned employees represent  
18 pay increases under Section 169.07 of the Codified Ordinances of the County of Summit, County  
19 Council's approval of the salary adjustments is required; and

21 WHEREAS, the Director of the County Executive's Department of Human Resources  
22 will review the personnel actions for the aforementioned salary adjustments as required by  
23 Section 169.07(b) of the Codified Ordinances; and

25 WHEREAS, the salary adjustments will be submitted to the Director of the Executive's  
26 Department of Finance and Budget for certification of availability of appropriated funds, as  
27 required by Section 169.07(b) of the Codified Ordinances; and

29 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
30 that it is necessary and in the best interest of the County of Summit to approve and authorize the  
31 Sheriff to make the aforementioned salary adjustments effective retroactively to January 1, 2018;

33 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
34 of Ohio, that:

7 welfare of the citizens of the County of Summit and for the further reason to immediately  
8 approve and authorize the Sheriff to timely make the aforementioned salary adjustments for the  
9 classified non-bargaining employees listed above effective retroactively to January 1, 2018.

13 Provided this Resolution receives the affirmative vote of eight members, it shall take  
14 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
15 effect and be in force at the earliest time provided by law.


