7 **A Resolution authorizing the County Executive to execute a Local Public Agency**
8 **agreement with the State of Ohio, through the Department of Transportation for a county-**
9 **wide Ball Bank Study, in Council Districts 1, 4, 5, and 8, for an estimated total cost of**
10 **\$9,800.00, with a 10% local cash match requirement not to exceed \$980.00, for the County**
11 **Engineer, and declaring an emergency.**

12

13 WHEREAS, a county-wide Ball Bank Study has been approved for Federal Highway
14 Administration funding, Project Identification (“PID”) Number 106861 (the “Study”); and

15

16 WHEREAS, the Study’s estimated total cost is \$9,800.00; and

17

18 WHEREAS, the Federal Highway Administration monies have been awarded to the
19 County Engineer’s office for a grant to cover the 90% of the Study, in the amount of \$8,820.00,
20 with a 10% local cash match requirement not to exceed \$980.00 which will be paid from Motor
21 Vehicle and Gas Tax funds; and

23 WHEREAS, the Ohio Department of Transportation (“ODOT”) and the County Engineer
24 desire to enter into a Local Public Agency (“LPA”) agreement, to confirm the Study’s Cost and
25 to designate the County of Summit as the lead agency for administration of the Study; and

27 WHEREAS, Sections 5501.03 and 5543.01 of the Ohio Revised Code, and Article II,
28 Section 2.03(5) of the County of Summit Charter allow execution of such agreements, subject to
29 the approval of this Council; and

31 WHEREAS, said LPA Agreement will state ODOT shall provide to the LPA \$8,820.00
32 in eligible costs from Federal Highway Administration funds; and

34 WHEREAS, this Council has determined by reviewing all pertinent information that
35 authorizing the County Executive to enter into the aforementioned LPA agreement with ODOT
36 is necessary and in the best interest of the County of Summit;

38 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
39 of Ohio, that:

41 SECTION 1

43 The County Executive is hereby authorized to execute a Local Public Agency agreement
44 with the State of Ohio, through the Department of Transportation (“ODOT”), for a county-wide
45 Ball Bank Study, Project Identification (“PID”) Number 106861 in Council Districts 1, 4, 5, and
46 8, for an estimated total cost of \$9,800.00, with 80% of the cost, in the amount of \$8820.00, to be
47 provided by ODOT, with a 10% local cash match requirement not to exceed \$980.00. The
48 Executive is hereby authorized to execute said LPA agreement in substantially the form attached
49 hereto as Exhibit A. Upon receipt of federal authorization from ODOT, the County may
50 commence the administration of the Project, with any award related to the Project subject to
51 applicable Codified Ordinances of the County of Summit, said Codified Ordinances of requiring
52 authorization of any such award by the Board of Control and/or County Council.
