7 **A Resolution authorizing the County Executive to execute a three-year policing contract**  
8 **with Coventry Township, in Council District 8, for the period 1/1/18 through 12/31/20, in**  
9 **exchange for payment by Coventry Township of a total amount of \$2,664,156.62 during the**  
10 **three-year term of the contract, for the Sheriff, and declaring an emergency.**

11  
12 WHEREAS, County Council previously adopted Resolution No. 2015-120, which  
13 authorized the County Executive to execute a three-year policing contract with Coventry  
14 Township, in Council District 8, which expired on 12/31/17; and

15  
16 WHEREAS, Coventry Township has requested that the County of Summit enter into a  
17 new contract pursuant to which the County Sheriff will provide 9,960.00 deputy/sergeant hours,  
18 for the period 1/1/18 through 12/31/20, and

19  
20 WHEREAS, Coventry Township has agreed to pay the County \$863,125.35 for the first  
21 year, \$887,798.93 for the second year and \$913,232.34 for the third year, for a total amount of  
22 \$2,664,156.62 during the three-year term of the contract; and

24 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
25 that it is necessary and in the best interest of the County of Summit to authorize the County  
26 Executive to execute the aforementioned policing contract with Coventry Township;

28 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
29 of Ohio, that;

31 SECTION 1

32  
33 The County Executive is hereby authorized to execute a three-year policing contract with  
34 Coventry Township, in Council District 8, pursuant to which the County Sheriff will provide  
35 Coventry Township with 9,960.00 deputy/sergeant hours, for the period of 1/1/18 through  
36 12/31/20, in exchange for payment by Coventry Township, in the amount of \$863,125.35 for the  
37 first year, \$887,798.93 for the second year and \$913,232.34 for the third year, for a total amount  
38 of \$2,664,156.62 during the three-year term of the contract.

40 SECTION 2

42 This Resolution is hereby declared an emergency in the interest of the health, safety and  
43 welfare of the citizens of the County of Summit and for the further reason to immediately  
44 provide necessary policing for Coventry Township, in Council District 8, effective 1/1/18.

46 SECTION 3

47  
48 Provided this Resolution receives the affirmative vote of eight members, it shall take  
49 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
50 effect and be in force at the earliest time provided by law.
