7 **A Resolution authorizing the County Executive to execute a one-year policing contract with**  
8 **the County of Summit Developmental Disabilities Board, for the period 1/1/18 through**  
9 **12/31/18, in exchange for payment by the Board of \$228,639.12, for the Sheriff, and**  
10 **declaring an emergency.**

11  
12 WHEREAS, the County of Summit Developmental Disabilities Board (“DD Board”)  
13 wishes to enter into a one-year policing contract with the County of Summit to provide two  
14 County Sheriff’s Deputies and two one-third shifts of a vehicle, for the period 1/1/18 through  
15 12/31/18; and

17 WHEREAS, the DD Board has agreed to pay the County the amount of \$19,053.26 per  
18 month, for total of \$228,639.12 for the period 1/1/18 through 12/31/18; and

20 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
21 that it is necessary and in the best interest of the County of Summit to authorize the County  
22 Executive to execute the aforementioned policing contract with the DD Board;

24 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
25 of Ohio, that;

27 SECTION 1

29 The County Executive is hereby authorized to execute a one-year policing contract with  
30 the County of Summit Developmental Disabilities Board (“DD Board”), to provide two Sheriff’s  
31 Deputies and two one-third shifts of a vehicle, for the period 1/1/18 through 12/31/18, in  
32 exchange for payment by the DD Board of \$19,053.26 per month, for a total amount of  
33 \$228,639.12 for the one-year term of the policing contract.

37 This Resolution is hereby declared an emergency in the interest of the health, safety, and  
38 welfare of the citizens of the County of Summit and for the further purpose of immediately  
39 providing necessary policing to County of Summit Developmental Disabilities Board effective  
40 1/1/18.

44 Provided this Resolution receives the affirmative vote of eight members, it shall take  
45 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
46 effect and be in force at the earliest time provided by law.
