7 **A Resolution authorizing the County Executive to execute a three-year policing contract**
8 **with City of Green, in Council District 8, in exchange for payment by the City of Green a**
9 **total amount of \$8,589,589.16 during the three-year term of the contract, for the Sheriff,**
10 **and declaring an emergency.**

12 WHEREAS, County Council previously adopted Resolution No. 2015-006, which
13 authorized the County Executive to execute a three-year policing contract with the City of Green
14 in Council District 8, which expired on 12/31/17; and

15
16 WHEREAS, City of Green has requested that the County of Summit enter into a new
17 contract pursuant to which the County Sheriff will provide 37,153.22 deputy/sergeant hours
18 annually, for the period 1/1/18 through 12/31/20, and

19
20 WHEREAS, City of Green has agreed to pay the County \$2,776,566.02 for the first year,
21 \$2,862,322.25 for the second year and \$2,950,700.89 for the third year, for a total amount of
22 \$8,589,589.16 during the three-year term of the contract; and

24 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
25 that it is necessary and in the best interest of the County of Summit to authorize the County
26 Executive to execute the aforementioned policing contract with City of Green;

28 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
29 of Ohio, that;

31 SECTION 1

33 The County Executive is hereby authorized to execute a three-year policing contract with
34 City of Green, in Council District 8, pursuant to which the County Sheriff will provide City of
35 Green with 37,153.22 deputy/sergeant hours annually, for the period of 1/1/18 through 12/31/20,
36 in exchange for payment by City of Green in the amount of \$2,776,566.02 for the first year,
37 \$2,862,322.25 for the second year and \$2,950,700.89 for the third year, for a total amount of
38 \$8,589,589,16 during the three-year term of the contract.

42 This Resolution is hereby declared an emergency in the interest of the health, safety and
43 welfare of the citizens of the County of Summit and for the further reason to immediately
44 provide necessary policing for City of Green, in Council District 8, effective 1/1/18.

48 Provided this Resolution receives the affirmative vote of eight members, it shall take
49 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
50 effect and be in force at the earliest time provided by law.
