7 **A Resolution confirming an award by the Board of Control for a renewal (first of four) of a**  
8 **professional service contract with Oriana House, Inc. for community corrections services**  
9 **for a one year term, from 1/1/18 through 12/31/18, in an amount not to exceed**  
10 **\$5,921,097.39, for the Executive's Department of Law, Insurance and Risk Management-**  
11 **Division of Public Safety and declaring an emergency.**

12

13 WHEREAS, on September 12, 2016, the County of Summit solicited five (5) providers of  
14 community corrections programs and advertised Requests for Proposals to provide day reporting,  
15 driver intervention, home incarceration, multiple offender and residential community corrections  
16 services; and

17

18 WHEREAS, on the deadline of October 10, 2016, Oriana House, Inc. was the only  
19 provider to submit a proposal for each program; and

20

21 WHEREAS, County Council adopted Resolution No. 2016-433, which confirmed an  
22 award by the Board of Control a professional service contract with Oriana House, Inc. for day  
23 reporting, driver intervention, home incarceration, multiple offender, pretrial services and  
24 residential community corrections programs, for the period 1/1/17 through 12/31/17, in an  
25 amount not to exceed \$5,921,097.39, with four options to renew for an additional one-year term,  
26 with the cost of any renewal term to be equal to the increase in the Consumer Price Index or  
27 three percent, whichever is less; and

29 WHEREAS, the County wishes to execute a renewal (first of four) of a professional  
30 service contract with Oriana House, Inc., for community corrections program services, for the  
31 period 1/1/18 through 12/31/18, in an amount not to exceed \$5,921,097.39; and

33 WHEREAS, on 1/3/18, the Board of Control awarded a renewal (first of four) of the  
34 aforementioned professional service contract with Oriana House, Inc., for community corrections  
35 program services, subject to confirmation by County Council; and

37 WHEREAS, this Council has determined by reviewing all pertinent information that a  
38 renewal (first of four) of the aforementioned professional service contract with Oriana House,  
39 Inc. is necessary and in the best interest of the County of Summit;

41 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
42 of Ohio, that:

46 The award by the Board of Control of a renewal (first of four) of a professional service  
47 contract with Oriana House, Inc., for community corrections services, for the period 1/1/18  
48 through 12/31/18, in an amount not to exceed \$5,921,097.39, is hereby confirmed and the  
49 County Executive is hereby authorized to execute such renewal.
