12 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
13 requires this Council's authorization for the County Executive to advertise for bids; and

15 WHEREAS, the County Executive wishes to advertise for bids for the purchase of
16 various types of office paper to stock in 2018, for an estimated total cost not to exceed
17 \$150,000.00; and

19 WHEREAS, a copy of the bid specifications are attached as Exhibit A; and

21 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
22 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
23 advertise for bids for the purchase of various types of office paper to stock in 2018, for an
24 estimated total cost not to exceed \$150,000.00;

37 of the citizens of the County of Summit, and for the further reason that it authorizes the
38 Executive to immediately advertise for bids for the purchase of various types of office paper to

44 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
