8 **Employment Program Monitoring Services Agreements with certain providers, for the**
9 **period 5/1/18 through 9/30/18, for monitoring services, work readiness skills training, and**
10 **other additional services, in a total amount not to exceed \$270,000.00, for the Executive's**
11 **Department of Job and Family Services, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held April 25, 2018, awarded Summer
14 Youth Employment Program ("SYEP") Monitoring Services Agreements with certain providers,
15 per the attached Exhibit A, for monitoring services, work readiness skills training and other
16 additional services, for the period of 5/1/18 through 9/30/18, in a total amount not to exceed
17 \$270,000.00, subject to confirmation by County Council; and

19 WHEREAS, this Council finds and determines after reviewing all pertinent information
20 that the aforementioned SYEP Monitoring Services Agreements are necessary and in the best
21 interest of the County of Summit;

28 The award by the Board of Control for Summer Youth Employment Program ("SYEP")
29 Monitoring Services Agreements with certain providers, per attached Exhibit A, for monitoring
30 services, work readiness skills training and other additional services, for the period 5/1/18
31 through 9/30/18, in a total amount not to exceed \$270,000.00, is hereby confirmed and the
32 County Executive is hereby authorized to execute such agreements.

36 This Resolution is hereby declared an emergency in the interest of the health, safety and
37 welfare of the citizens of the County of Summit, and for the further reason to immediately
38 provide for SYEP monitoring services, work readiness skills training and other additional
39 services effective 5/1/18.

44 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
