7 **A Resolution confirming an award by the Board of Control of a professional service**
8 **contract with GPD Group, Inc., for 2018 CEAO Road Segment and Intersection Safety**
9 **Studies, for a total amount not to exceed \$72,000.00, for the Engineer, and declaring an**
10 **emergency.**

12 WHEREAS, the Board of Control, at its meeting held April 25, 2018, awarded a
13 professional service contract with GPD Group, Inc. for 2018 CEAO Road Segment and
14 Intersection Safety Studies, for a total amount not to exceed \$72,000.00, subject to confirmation
15 by County Council; and

17 WHEREAS, County Council finds and determines, after reviewing all pertinent
18 information that the aforementioned professional service contract with GPD Group, Inc. is
19 necessary and in the best interest of the County of Summit;

21 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
22 of Ohio, that:

26 The award by the Board of Control of a professional service contract with GPD Group,
27 Inc. for 2018 CEAO Road Segment and Intersection Safety Studies, for a total amount not to
28 exceed \$72,000.00, is hereby confirmed and the County Executive is hereby authorized to
29 execute such professional service contract.

31 SECTION 2

33 This Resolution is hereby declared an emergency in the interest of the health, safety and
34 welfare of the citizens of Summit County, and for the further reason to allow the Engineer to
35 complete safety studies in a timely manner.

39 Provided this Resolution receives the affirmative vote of eight members, it shall take
40 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
41 effect and be in force at the earliest time provided by law.

45 It is found and determined that all formal actions of this Council concerning and relating
46 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
47 deliberations of this Council and of any of its committees that resulted in such formal action,


