7 **A Resolution authorizing the County Executive to execute a construction contract with H. Luli**  
8 **Construction, subject to the approval of the Board of Control, for the 2018 Summit County**  
9 **Regional 422 Resurfacing Program, in an amount not to exceed \$1,262,868.86, for the**  
10 **Engineer, and declaring an emergency.**

11  
12 WHEREAS, this Council previously adopted Resolution No. 2018-059, which authorized the  
13 Engineer to advertise as needed for bridge engineering and construction projects, and pavement  
14 maintenance projects, for the County Engineer's 2018 Capital Improvements Program, and federal  
15 and state funded projects, at an estimated cost not to exceed \$8,129,500.00; and

16  
17 WHEREAS, following the receipt and review of bids, the County Executive wishes to enter  
18 into a construction contract with H. Luli Construction, subject to the approval of the Board of  
19 Control, for the 2018 Summit County Regional 422 Resurfacing Program, in an amount not to  
20 exceed \$1,262,868.86; and

22 WHEREAS, this Council finds and determines, after reviewing all pertinent information, that  
23 it is necessary and in the best interest of the County of Summit to authorize the County Executive to  
24 execute the aforementioned construction contract with H. Luli Construction, subject to the approval  
25 of the Board of Control;

27 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of  
28 Ohio, that:

30 SECTION 1

32 The County Executive is hereby authorized to execute a construction contract with H. Luli  
33 Construction, subject to the approval of the Board of Control, for the 2018 Summit County Regional  
34 422 Resurfacing Program, in an amount not to exceed \$1,262,868.86.

36 SECTION 2

38 This Resolution is hereby declared an emergency in the interest of health, safety and welfare  
39 of the citizens of the County of Summit, and for the further reason to immediately provide necessary  
40 pavement repairs.

42 SECTION 3

44 Provided this Resolution receives the affirmative vote of eight members, it shall take effect  
45 immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in  
46 force at the earliest time provided by law.


