7 **A Resolution authorizing the County Executive to execute a construction contract with**
8 **Perrin Asphalt Co., subject to the approval of the Board of Control, for the 2018 Summit**
9 **County 448 Resurfacing Program - South, in an amount not to exceed \$1,527,598.30, for**
10 **the Engineer, and declaring an emergency.**

11
12 WHEREAS, this Council previously adopted Resolution No. 2018-059, which authorized
13 the Engineer to advertise as needed for bridge engineering and construction projects, and
14 pavement maintenance projects, for the County Engineer's 2018 Capital Improvements Program,
15 and federal and state funded projects, at an estimated cost not to exceed \$8,129,500.00; and

16
17 WHEREAS, following the receipt and review of bids, the County Executive wishes to
18 enter into a construction contract with Perrin Asphalt Co., subject to the approval of the Board of
19 Control, for the 2018 Summit County 448 Resurfacing Program – South, to provide necessary
20 repairs to various County, Copley Township, and City of Norton roads, in an amount not to
21 exceed \$1,527,598.30; and

23 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
24 that it is necessary and in the best interest of the County of Summit to authorize the County
25 Executive to execute the aforementioned construction contract with Perrin Asphalt Co., subject
26 to the approval of the Board of Control;

28 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
29 of Ohio, that:

33 The County Executive is hereby authorized to execute a construction contract with Perrin
34 Asphalt Co., subject to the approval of the Board of Control, for the 2018 Summit County 448
35 Resurfacing Program - South, to provide necessary repairs to various County, Copley Township,
36 and City of Norton roads, in an amount not to exceed \$1,527,598.30.

40 This Resolution is hereby declared an emergency in the interest of health, safety and
41 welfare of the citizens of the County of Summit, and for the further reason to immediately
42 provide necessary repairs to various County, Copley Township, and City of Norton roads.

46 Provided this Resolution receives the affirmative vote of eight members, it shall take
47 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
48 effect and be in force at the earliest time provided by law.
