7 **A Resolution approving the manner and method of billing and collection for the Surface**
8 **Water Management District in accordance with Section 942.07(b) of the Codified**
9 **Ordinances of the County of Summit, for the Engineer, and declaring an emergency.**

11 WHEREAS, Section 942.07(b) of the Codified Ordinances of the County of Summit
12 states, "Prior to the commencement of any billing and collection of the Surface Water
13 Management Service Charge and any other fees, the County Engineer shall submit a plan setting
14 forth the manner, method, and other details for said billing and collection to the County Council.
15 The County Engineer shall not begin the billing and collection of the Surface Water Management
16 Service Charge or any other fee until said plan is reviewed and approved by the County
17 Executive and County Council"; and

19 WHEREAS, the County Engineer has proposed the Surface Water Management District
20 Billing and Collection Plan (the "Plan"), which is attached hereto as Exhibit A and incorporated
21 herein by reference; and

23 WHEREAS, the County Engineer has presented the Plan to the County Executive, and by
24 way of introducing this Resolution to this Council, the County Executive has indicated her
25 approval of the Plan; and

27 WHEREAS, pursuant to the Plan, in order to notify owners of real property in Bath
28 Township, advertisements will be placed in the May editions of the Bath Country Journal and
29 Bath Township Newsletter, and three times in the West Side Leader; and

30
31 WHEREAS, pursuant to the Plan, the County Engineers plans to print and mail bills for
32 an estimated cost not to exceed \$3,500.00, including postage, and intends to contract with KMS
33 2000, Inc. dba PPI Graphics to print and mail said bills; and

35 WHEREAS, pursuant to the Plan, employees of the County Engineer's Office will
36 process and deposit payments internally; and

37
38 WHEREAS, the Plan sets forth further details necessary to comply with Section
39 942.07(b); and

41 WHEREAS, this Council has determined, by reviewing all pertinent information, that it
42 is necessary and in the best interest of the County, to approve the Plan;

44 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
45 of Ohio, that:

49 Pursuant to Section 942.07(b) of the Codified Ordinances of the County of Summit, the
50 Surface Water Management District Billing and Collection Plan proposed by the County
51 Engineer and approved by the County Executive, a copy of which is attached hereto as Exhibit A
52 and incorporated herein, is hereby approved.

8 Surface Water Management District to begin work in the Bath Township Service Area to reduce
9 flooding and increase water quality.

13 Provided this Resolution receives the affirmative vote of eight members, it shall take
14 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
15 effect and be in force at the earliest time provided by law.


