7 **An Ordinance repealing Section 134.03 of the Codified Ordinances of the County of**
8 **Summit, entitled “Fees Schedule,” and enacting a new Section 134.03, entitled “Recording**
9 **Fees Schedule,” in order to set forth the recording fees which the County Fiscal Officer is**
10 **authorized to charge by the Ohio Revised Code, for the Fiscal Officer, and declaring an**
11 **emergency.**

13 WHEREAS, the County Fiscal Officer is authorized by the Ohio Revised Code to charge
14 certain fees for recording services her office provides; and

15
16 WHEREAS, it is necessary to repeal Section 134.03 of the Codified Ordinances of the
17 County of Summit, entitled “Fees Schedule,” and enact a new Section 134, entitled “Recording
18 Fees Schedule,” so that is it consistent with the Ohio Revised Code in setting forth the recording
19 fees which the County Fiscal Officer is authorized to charge; and

21 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
22 it is necessary and in the best interest of the County of Summit to repeal Section 134.03 and
23 enact a new Section 134.03 for the aforementioned reason; and

25 NOW, THEREFORE, BE IT ORDAINED by the Council of the County of Summit, State
26 of Ohio, that:

28 SECTION 1

30 Section 134.03 of the Codified Ordinances of the County of Summit, entitled “Fees
31 Schedule,” is hereby repealed in its entirety.

33 SECTION 2

35 Section 134.03 of the Codified Ordinances of the County of Summit, entitled “Recording
36 Fees Schedule,” is hereby enacted as set forth in Exhibit A, attached to this Resolution and
37 incorporated herein as if fully restated.

41 This Ordinance is hereby declared an emergency in the interest of the health, safety, and
42 welfare of the citizens of Summit County and for the further reason that it is necessary to
43 immediately repeal 134.03 of the Codified Ordinances of the County of Summit and enact a new
44 Section 134.04 so that recording fees set forth therein will be consistent with the fees which the
45 County Fiscal Officer is authorized to charge by the Ohio Revised Code.

49 Provided this Ordinance received the affirmative vote of eight members, it shall take
50 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
51 effect and be in force at the earliest time provided by law.


