7 **A Resolution confirming an award by the Board of Control of a purchase contract with**  
8 **D.W. Lift Sales, Inc., for one specialized flatbed heavy duty truck for the Ohio Region 5**  
9 **Type II Collapse Search and Rescue Team, in an amount not to exceed \$108,962.87, for the**  
10 **Executive's Department of Law, Insurance and Risk Management-Division of Public**  
11 **Safety, and declaring an emergency.**

13 WHEREAS, this Council previously adopted Resolution No. 2018-126, which authorized  
14 the County Executive to advertise for bids for a specialized flatbed heavy truck for the Ohio  
15 Region 5 Type II Collapse Search and Rescue Team, for an estimated total cost not to exceed  
16 \$130,000.00; and

18 WHEREAS, the Board of Control, at its meeting held May 9, 2018, awarded a purchase  
19 contract with D.W. Lift Sales, Inc., for one specialized flatbed heavy duty truck for the Ohio  
20 Region 5 Type II Collapse Search and Rescue Team, in an amount not to exceed \$108,962.87,  
21 subject to confirmation by County Council; and

23 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
24 that the aforementioned purchase contract with D.W. Lift Sales, Inc. is necessary and in the best  
25 interest of the County of Summit;

27 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
28 of Ohio, that:

32 The award by the Board of Control of a purchase contract with D.W. Lift Sales, Inc., for  
33 one specialized flatbed heavy duty truck for the Ohio Region 5 Type II Collapse Search and  
34 Rescue Team, in an amount not to exceed \$108,962.87, is hereby confirmed and the County  
35 Executive is hereby authorized to execute such purchase contract.

39 This Resolution is hereby declared an emergency in the interest of health, safety and  
40 welfare of the residents of the County of Summit, and for the further reason to immediately  
41 provide necessary equipment for the Ohio Region 5 Type II Collapse Search and Rescue Team.

45 Provided this Resolution receives the affirmative vote of eight members, it shall take  
46 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
47 effect and be in force at the earliest time provided by law.
