7 **A Resolution authorizing the County Executive to advertise for bids for inmate pay phone**  
8 **services at the County of Summit Jail, for a one-year term, with five options to renew for**  
9 **an additional one-year term, for the Sheriff, and declaring an emergency.**

11 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit  
12 requires this Council's authorization for the County Executive to advertise for bids; and

13  
14 WHEREAS, the County Executive wishes to advertise for bids for inmate pay phone  
15 services at the County of Summit Jail, for a one-year term, with five options to renew for an  
16 additional one-year term; and

18 WHEREAS, the current inmate pay phone services contract for the County of Summit  
19 Jail expires on 7/14/18; and

21 WHEREAS, a copy of the bid specifications is on file in the Clerk of Council's office;

24 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
25 that it is necessary and in the best interest of the County of Summit to authorize the Executive to  
26 advertise for bids for a new inmate pay phone services contract for the Jail for a one-year term,  
27 with five options to renew for an additional one-year term;

29 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
30 of Ohio, that:

34 The County Executive is authorized to advertise for bids for inmate pay phone services at  
35 the County of Summit Jail, for a one-year term, with five options to renew for an additional one-  
36 year term.

38 SECTION 2

40 This Resolution is hereby declared an emergency in the interest of the health, safety and  
41 welfare of the residents of the County of Summit, and for the further purpose to immediately  
42 provide inmate pay phone services at the County Jail in 2018.

46 Provided this Resolution receives the affirmative vote of eight members, it shall take  
47 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
48 effect and be in force at the earliest time provided by law.
