A Resolution declaring the month of June 2018 as Alzheimer's and Brain Awareness Month in Summit County, and to raise awareness about Alzheimer's disease and other brain diseases and dementias for the Council and the Executive, and declaring an emergency.

WHEREAS, An estimated 5.7 million Americans are living with Alzheimer's disease and that number is expected to rise by 14 million people within the next thirty years; and

WHEREAS, In the United States, Alzheimer's ranks as the 6th leading cause of death, claiming more lives than breast cancer and prostate cancer combined; and

WHEREAS, 10% of people age 65 and over have been diagnosed with Alzheimer's disease. Women, African-Americans, and Hispanics are disproportionately affected by this disease, as two-thirds of Americans living with Alzheimer's are women, African-Americans are twice as likely to be affected by the disease, and Hispanics are one and one-half times as likely to be diagnosed with Alzheimer's in comparison with the older Caucasian population; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit that June 2018 be declared Alzheimer's and Brain Awareness Month in Summit County, and encouraging the residents of Summit County to join in this acknowledgement;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

RESOLUTION NO

The month of June 2018 is hereby declared Alzheimer's and Brain Awareness Month in Summit County, and encouraging the residents of Summit County to join in this acknowledgement.
