7 **A Resolution declaring the month of June 2018 as Alzheimer’s and Brain Awareness**
8 **Month in Summit County, and to raise awareness about Alzheimer’s disease and other**
9 **brain diseases and dementias for the Council and the Executive, and declaring an**
10 **emergency.**

12 WHEREAS, An estimated 5.7 million Americans are living with Alzheimer’s disease and
13 that number is expected to rise by 14 million people within the next thirty years; and

14
15 WHEREAS, In the United States, Alzheimer’s ranks as the 6th leading cause of death,
16 claiming more lives than breast cancer and prostate cancer combined; and

17
18 WHEREAS, 10% of people age 65 and over have been diagnosed with Alzheimer’s
19 disease. Women, African-Americans, and Hispanics are disproportionately affected by this
20 disease, as two-thirds of Americans living with Alzheimer’s are women, African-Americans are
21 twice as likely to be affected by the disease, and Hispanics are one and one-half times as likely to
22 be diagnosed with Alzheimer’s in comparison with the older Caucasian population; and

24 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
25 that it is necessary and in the best interest of the County of Summit that June 2018 be declared
26 Alzheimer’s and Brain Awareness Month in Summit County, and encouraging the residents of
27 Summit County to join in this acknowledgement;

29 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
30 of Ohio, that:

34 The month of June 2018 is hereby declared Alzheimer’s and Brain Awareness Month in
35 Summit County, and encouraging the residents of Summit County to join in this
36 acknowledgement.

40 This Resolution is hereby declared an emergency in the interest of the health, safety and
41 welfare of the citizens and employees of the County of Summit and for the further purpose of
42 immediately declaring June 2018 as Alzheimer’s and Brain Awareness Month in Summit
