7 **A Resolution confirming an award by the Board of Control authorizing the purchase of**  
8 **contracts for cyber liability and foreign travel liability insurance coverage for the County**  
9 **for a one-year term, from 7/1/18 to 7/1/19, for a total amount not to exceed \$19,370.65,**  
10 **payable through Wichert Insurance Services, Inc. dba Wichert Insurance, as a Best**  
11 **Practical Source, for the Executive's Department of Law, Insurance and Risk**  
12 **Management, and declaring an emergency.**

13  
14 WHEREAS, this Council previously adopted Resolution No. 2017-118, which confirmed  
15 the award by the Board of Control of a renewal (second and final) and amendment of a  
16 professional service contract with Wichert Insurance Services, Inc. dba Wichert Insurance  
17 ("Wichert") to provide brokerage services for the County's property, liability, boiler and  
18 machinery insurance program, and to provide Claim Reporting Services using Riskmaster, for a  
19 one-year term, from 7/1/7 through 6/30/18, in an amount not to exceed \$45,000.00; and

21 WHEREAS, this Council subsequently adopted Resolution No. 2018-121, which  
22 authorized the purchase of contracts for various types of insurance, subject to the approval of the  
23 Board of Control, for a one-year term, from 4/15/18 through 4/15/19, in an amount not to exceed  
24 \$910,106.00, payable through Wichert as a Best Practical Source; and

26 WHEREAS, Wichert conducted a search on the County's behalf for cyber liability and  
27 foreign travel liability insurance coverage for the County for a one-year term, from 7/1/18 to  
28 7/1/19, and provided the insurance proposal attached to this Resolution as Exhibit A; and

30 WHEREAS, the Board of Control, at its meeting on May 5, 2018, authorized the  
31 purchase of contracts for cyber liability and foreign travel liability insurance coverage for the  
32 County for a one-year term, from 7/1/18 to 7/1/19, for a total amount not to exceed \$19,370.65,  
33 payable through Wichert, as a Best Practical Source, subject to confirmation by County Council;  
34 and

36 WHEREAS, because Wichert has been directly paid in excess of \$50,000.00, Council  
37 approval of the purchase of the aforementioned insurance contracts is necessary; and

39 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
40 that it is necessary and in the best interest of the County of Summit to confirm the award by the  
41 Board of Control authorizing the purchase of the aforementioned insurance contracts for a one-  
42 year term, from 7/1/18 to 7/1/19, for a total amount not to exceed \$19,370.65, payable through  
43 Wichert, as a Best Practical Source;

6 The award by the Board of Control the purchase of contracts for cyber liability and  
7 foreign travel liability insurance coverage for the County for a one-year term, from 7/1/18 to  
8 7/1/19, for a total amount not to exceed \$19,370.65, payable through Wichert Insurance Services,  
9 Inc. dba Wichert Insurance, as a Best Practical Source, as set forth in Exhibit A, attached to this  
10 Resolution and incorporated herein as if fully restated, is hereby confirmed and the County  
11 Executive is hereby authorized to execute any documents necessary to effect the purchase of said  
12 contracts.

14 SECTION 2

16 This Resolution is hereby declared to be an emergency in the interest of the health, safety  
17 and welfare of the citizens of the County of Summit and for the further reason that it is necessary  
18 to immediately authorize the execution of contracts for cyber liability and foreign travel liability  
19 insurance coverage for 2018-2019 effective 7/1/18.

21 SECTION 3

23 Provided this Resolution receives the affirmative vote of eight members, it shall take  
24 effect immediately upon its adoption and approval by the Executive; otherwise it shall take effect  
25 and be in force at the earliest time provided by law.

29 It is found and determined that all formal actions of this Council concerning and relating  
30 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
31 deliberations of this Council and any of its committees that resulted in such formal action were in

33 the Ohio Revised Code.
