7 **A Resolution authorizing the County Executive to execute any documents necessary to**  
8 **accept the award of a Technology grant from the Ohio Supreme Court, to the Court of**  
9 **Common Pleas-General Division, for the period of 5/1/18 through 4/30/19, in the amount of**  
10 **\$19,950.00, with no local match requirement, and appropriating said grant funds, for the**  
11 **Court of Common Pleas-General Division, and declaring an emergency.**

13 WHEREAS, the Ohio Supreme Court has awarded a Technology grant to the Court of  
14 Common Pleas-General Division to fund the upgrade of evidence management features in  
15 SCORS, the Court’s case management system, for the period 5/1/18 through 4/30/19, in the  
16 amount of \$19,950.00, with no local cash match requirement,; and

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
19 that it is necessary and in the best interest of the County of Summit to authorize the County  
20 Executive to execute any documents necessary to accept the award of the aforementioned grant  
21 from the Ohio Supreme Court and to appropriate said grant funds;

28 The County Executive is hereby authorized to execute any documents necessary to accept  
29 the award of a Technology grant from the Ohio Supreme Court, to the Court of Common Pleas-

31 case management system, for the period of 5/1/18 through 4/30/19, in the amount of \$19,950.00,  
32 with no local cash match requirement.
