7 **A Resolution confirming an award by the Board of Control of a purchase contract with**  
8 **Montrose Ford, at CUE pricing, for three Ford Explorer Police Interceptors, one 2018**  
9 **Ford Explorer Police Interceptor, and one 2018 Ford Explorer Interceptor, in an amount**  
10 **not to exceed \$144,125.79, for the Sheriff, and declaring an emergency.**

12 WHEREAS, the Board of Control, at its meeting held May 9, 2018, awarded a purchase  
13 contract with Montrose Ford, at CUE pricing, for three Ford Explorer Police Interceptors, one  
14 2018 Ford Explorer Police Interceptor, and one 2018 Ford Explorer Interceptor, in an amount not  
15 to exceed \$144,125.79, for the Sheriff, subject to confirmation by County Council; and

17 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
18 that the aforementioned purchase contract with Montrose Ford is necessary and in the best  
19 interest of the County of Summit;

21 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
22 of Ohio, that:

24 SECTION 1

26 The award by the Board of Control of a purchase contract with Montrose Ford, at CUE  
27 pricing, for three Ford Explorer Police Interceptors, one 2018 Ford Explorer Police Interceptor,  
28 and one 2018 Ford Explorer Interceptor, in an amount not to exceed \$144,125.79, for the Sheriff,  
29 is hereby confirmed and the County Executive is hereby authorized to execute such purchase  
30 contract.

32 SECTION 2

34 This Resolution is hereby declared an emergency in the interest of health, safety and  
35 welfare of the citizens of the County of Summit, and for the further reason to immediately  
36 provide necessary equipment for the Sheriff.

38 SECTION 3

40 Provided this Resolution receives the affirmative vote of eight members, it shall take  
41 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
42 effect and be in force at the earliest time provided by law.

46 It is found and determined that all formal actions of this Council concerning and relating  
47 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
48 deliberations of this Council and of any of its committees that resulted in such formal action  
49 were in meetings open to the public, in compliance with all legal requirements, including Section  
50 121.22 of the Ohio Revised Code.
