7 **A Resolution adjusting existing appropriations, in the amount of \$41,000.00, from the**
8 **Contract Services account to the Salaries and Benefits accounts, for the Court of Common**
9 **Pleas – Juvenile Division, and declaring an emergency.**

11 WHEREAS, County Council previously adopted Resolution 2017-301, which authorized
12 the County Executive to execute any documents necessary to accept a grant from the County of
13 Summit Alcohol, Drug Addiction, and Mental Health Services Board for juvenile detention
14 behavioral health services, for the period 7/1/17 to 6/30/18, in the amount of \$245,346.00, with
15 no local cash match requirement, and appropriated funds, in the amount of \$110,151.37, for the
16 Court of Common Pleas – Juvenile Division; and

18 WHEREAS, it is necessary to adjust existing appropriations, in the amount of
19 \$41,000.00, from the Contract Services account to the Salaries and Benefits accounts, because
20 salaries were underestimated in that amount; and

22 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
23 that the aforementioned adjustment of appropriations is necessary and in the best interest of the
24 County of Summit;
