7 **A Resolution authorizing the County Executive to execute an amendment to a Cooperative**
8 **Agreement with the City of New Franklin wherein the County agreed to contribute**
9 **towards the cost of the construction and easement acquisition for the Manchester Road**
10 **Widening and Sanitary Sewer Extension Project, in the City of New Franklin, in Council**
11 **District 7, to increase the County's contribution towards the same, and appropriating**
12 **funds to provide for the increased contribution, for the Executive's Department of Sanitary**
13 **Sewer Services, and declaring an emergency.**

14
15 WHEREAS, pursuant to Resolution No. 2016-428, this Council authorized the County
16 Executive to execute a Cooperative Agreement with the City of New Franklin to contribute
17 towards the cost of construction and easement acquisition for the Manchester Road Widening
18 and Sanitary Sewer Extension Project Q-834-2B ("Project"), in the City of New Franklin, in
19 Council District 7, in an amount not to exceed \$583,701.51; and

20
21 WHEREAS, due to increases in the cost of the Project, the County's contribution towards
22 the cost of the Project is expected to exceed the initial contribution amount of \$583,701.51 by an
23 additional \$47,759.17, for a total amount not to exceed \$631,460.68; and

25 WHEREAS, it is necessary to execute an amendment to the aforementioned Cooperative
26 Agreement to increase the amount of the County's contribution by an additional \$47,759.17, for
27 a total amount not to exceed \$631,460.68; and

29 WHEREAS, it is further necessary to appropriate additional finds in the amount of
30 \$47,759.17 to pay for the County's increased contribution; and

32 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
33 that it is necessary and in the best interest of the County of Summit to authorize the County
34 Executive to execute the aforementioned amendment to the Cooperative Agreement and to
35 appropriate the necessary additional funds;

37 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
38 of Ohio, that:

42 The County Executive is hereby authorized to execute an amendment to a Cooperative
43 Agreement with the City of New Franklin wherein the County agreed to contribute towards the
44 cost of the construction and easement acquisition for the Manchester Road Widening and
45 Sanitary Sewer Extension Project, in the City of New Franklin, in Council District 7, to increase
46 the County's contribution towards the same by an additional \$47,759.17, for a total amount not
47 to exceed \$631,460.68.

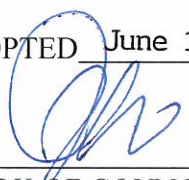

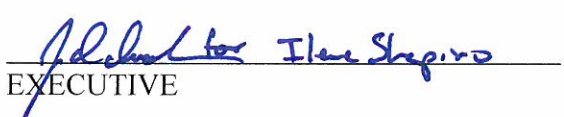
