7 **A Resolution authorizing the County Executive to advertise for bids for a roof replacement**
8 **project at the Juvenile Court Building, in Council District 2, for an estimated total cost not to**
9 **exceed \$220,000.00, for the Executive's Department of Administrative Services-Physical Plants**
10 **Division, and declaring an emergency.**

12 WHEREAS, the County Executive wishes to advertise for bids for the roof replacement
13 project at the Juvenile Court Building, in Council District 2, for an estimated total cost not to exceed
14 \$220,000.00; and

15
16 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit requires
17 this Council's authorization for the County Executive to advertise for bids; and

18
19 WHEREAS, this Council previously adopted Resolution No. 2018-088, which authorized the
20 County Executive to advertise for bids the roof replacement project at the Juvenile Court Building,
21 for an estimated cost not to exceed \$120,000; and

23 WHEREAS, the original estimate for the aforementioned project was underestimated and
24 accordingly, it is necessary to advertise for new bids; and

26 WHEREAS, a copy of the bid specifications is on file in the Clerk of Council's office; and

28 WHEREAS this Council finds and determines, after reviewing all pertinent information that
29 it is necessary and in the best interest of the County of Summit to authorize the Executive to
30 advertise for bids for the aforementioned project;

32 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of
33 Ohio, that:

35 SECTION 1

37 The County Executive is authorized to advertise for bids for the roof replacement project at
38 the Juvenile Court Building, in Council District 2, or an estimated total cost not to exceed
39 \$220,000.00.

41 SECTION 2

43 This Resolution is hereby declared an emergency in the interest of the health, safety and
44 welfare of the residents of the County of Summit, and for the further reason that it authorizes the
45 Executive to immediately advertise for bids for the aforementioned roof replacement project at the
46 Juvenile Court Building, in order to prolong the service life of the County facility.

50 Provided this Resolution receives the affirmative vote of eight members, it shall take effect
51 immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in
52 force at the earliest time provided by law.
