7 **A Resolution authorizing the County Executive to advertise for bids for the Summit**
8 **County Courthouse fourth floor renovation project, in Council District 4, for an estimated**
9 **total cost not to exceed \$182,000.00, for the Executive's Department of Administrative**
10 **Services-Physical Plants Division, and declaring an emergency.**

12 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
13 requires this Council's authorization for the County Executive to advertise for bids; and

15 WHEREAS, the County Executive wishes to advertise for bids for the Summit County
16 Courthouse fourth floor renovation project, in Council District 4, for an estimated total cost not
17 to exceed \$182,000.00; and

19 WHEREAS, a copy of the bid specifications is on file in the Clerk of Council's office;

22 WHEREAS this Council finds and determines, after reviewing all pertinent information,
23 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
24 advertise for bids for the Summit County Courthouse fourth floor renovation project;

26 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
27 of Ohio, that:

31 The County Executive is authorized to advertise for bids for the Summit County
32 Courthouse fourth floor renovation project, in Council District 4, for an estimated total cost not
33 to exceed \$182,000.00.

37 This Resolution is hereby declared an emergency in the interest of the health, safety and
38 welfare of the residents of the County of Summit, and for the further reason that it authorizes the
39 Executive to immediately advertise for bids for the aforementioned renovation project, in order
40 for the project to proceed as expeditiously as possible.

44 Provided this Resolution receives the affirmative vote of eight members, it shall take
45 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
46 effect and be in force at the earliest time provided by law.


