7 **A Resolution appropriating grant funds from the State of Ohio Department of**
8 **Rehabilitation and Correction, through the Targeted Community Alternatives to Prison**
9 **grant for State Fiscal Year 2019, in the amount of \$1,633,865.00, with no local cash match**
10 **requirement, for the period 7/1/18 through 6/30/19 for the Executive’s Department of Law,**
11 **Insurance and Risk Management – Division of Public Safety, and declaring an emergency.**

12

13 WHEREAS, the State of Ohio Department of Rehabilitation and Correction (ODRC) has
14 created the Targeted Community Alternatives to Prison (“TCAP”) grant program to provide
15 funding to local communities as a result of changes in the Ohio Revised Code, which will
16 prohibit some fifth degree felony offenders from serving a prison sentence in an Ohio prison on
17 or after July 1, 2018; and

18

19 WHEREAS, ODRC has identified Summit County as a target county, which provided
20 Summit County the opportunity to voluntarily participate in the State Fiscal Year (SFY) 2018
21 TCAP program and requires participation in SFY 2019; and

22

23 WHEREAS, the Summit County Executive, Summit County Sheriff and Administrative
24 Judge of the Court of Common Pleas, have agreed on a plan to use this funding to enhance
25 programming and supervision alternatives to be able to maintain the TCAP population locally
26 (“Summit County TCAP Plan”); and

28 WHEREAS, this Council previously adopted Resolution 2017-407, which authorized the
29 County Executive to accept the SFY 2018 and 2019 TCAP grant awards from ODRC, in the
30 amounts of \$1,336,798.00 and \$1,633,865.00 respectively, with no local cash match requirement
31 for the period 10/9/17 through 6/30/19; and

33 WHEREAS, this Council through Resolution 2017-437 previously appropriated the SFY
34 2018 TCAP grant award; and

35

36 WHEREAS, it is necessary to appropriate the SFY 2019 grant funds to support the
37 Summit County TCAP Plan; and

39 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
40 that it is necessary and in the best interest of the County of Summit to appropriate the SFY 2019
41 TCAP grant funds in a total amount of \$1,633,865.00, with no local cash match requirement;

43 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
