7 **A Resolution authorizing the County Executive to execute an Intergovernmental**
8 **Agreement with the City of Akron for the boarding at the Summit County Jail of**
9 **misdemeanor offenders charged under a City of Akron ordinance or charged with**
10 **contempt of an Akron Municipal Court Judge, for a term of five years, from January 1,**
11 **2018 to December 31, 2023, with four options to renew for five-year terms, for the Sheriff,**
12 **and declaring an emergency.**

14 WHEREAS, since 1993, the County has boarded certain City of Akron offenders charged
15 with misdemeanor offenses under a City of Akron ordinance or charged with contempt of an
16 Akron Municipal Court Judge pursuant to an Intergovernmental Agreement with the City of
17 Akron; and

18

19 WHEREAS, the aforementioned Intergovernmental Agreement with the City of Akron
20 terminated in February 2018; and

21

22 WHEREAS, the County Sheriff and County Executive have negotiated a new
23 Intergovernmental Agreement with the City of Akron for the boarding at the Summit County Jail
24 of misdemeanor offenders charged under a City of Akron ordinance or charged with contempt of
25 an Akron Municipal Court Judge, for a term of five years, from January 1, 2018 to December 31,
26 2023, with four options to renew for five-year terms, a copy of which is attached hereto as
27 Exhibit A, and incorporated herein by reference; and

29 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
30 that it is necessary and in the best interest of the County of Summit to authorize the County
31 Executive to execute the aforementioned Intergovernmental Agreement;

33 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
34 of Ohio, that:

36 SECTION 1

37

38 The County Executive is hereby authorized to execute an Intergovernmental Agreement
39 with the City of Akron for the boarding at the Summit County Jail of misdemeanor offenders
40 charged under a City of Akron ordinance or charged with contempt of an Akron Municipal Court
41 Judge, for a term of five years, from January 1, 2018 to December 31, 2023, with four options to
42 renew for five-year terms, a copy of which is attached hereto as Exhibit A and incorporated
43 herein by reference, with such modifications and revisions as shall be in furtherance of the
44 provisions of said agreement, and not substantially adverse to the County, all of which shall be
45 conclusively evidenced by the execution thereof by the County Executive.

47 SECTION 2

49 This Resolution is hereby declared an emergency in the interest of the health, safety and
50 welfare of the residents of the County of Summit, and for the further reason to immediately
51 authorize the boarding of the aforementioned offenders pursuant to the aforementioned
52 Cooperative Agreement.
