15 more fully set forth on Exhibit A, attached hereto and incorporated herein by reference, subject
16 to confirmation by County Council; and

19 WHEREAS, this Council finds and determines after reviewing all pertinent information
20 that the aforementioned professional service contracts with certain providers are necessary and in
21 the best interest of the County of Summit;

28 The award by the Board of Control of professional service contracts with certain
29 providers, for delinquent care and custody grant services, for the period 7/1/18 through 6/30/19,
30 in a total amount not to exceed \$1,897,394.00, as more fully set forth on Exhibit A, attached
31 hereto and incorporated herein by reference, is hereby authorized and the County Executive is
32 hereby authorized to executed the aforementioned professional services contracts.

36 This Resolution is hereby declared an emergency in the interest of the health, safety and
37 welfare of the residents of the County of Summit, and for the further reason to immediately
38 provide for delinquent care and custody grant services effective 7/1/18.

42 Provided this Resolution receives the affirmative vote of eight members, it shall take
43 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
44 effect and be in force at the earliest time provided by law.
