

**COUNTY OF SUMMIT**

**April 29, 2013**

A Caucus was held prior to the meeting to discuss Agenda items. Council members Comunale, Crawford, Feeman, Kostandaras, Kurt, Lee, Prentice, Rodgers, Roemer, Schmidt, Shapiro were present.

Nick Kostandaras and Jerry Feeman presented a Commendation to Ashley Morrisette of Twinsburg High School.

Executive Pry opposes adding a second judge as it would impact the general fund at least \$300,000 and also commended Judge Linda Teodosio on the excellent work she does at the court and how well it is operated. Judge Linda Tucci Teodosio shared a power point and handed out two packets of statistics from the Ohio Supreme Court showing how efficient Summit County is in this regard with one judge in comparison to other similar counties with two or more judges. Judge Teodosio plans to testify against this at the Senate. Sheriff Steve Barry also was present and agrees that money is needed elsewhere in the County. The Jail is still understaffed. Julie Schafer spoke on behalf of the Foster Care Association. Ms. Schafer is in favor of a second judge.
